## REV. BENJAMIN DOGGET'S FAMILY

Chapter 1. Rev. Benjamin Doggett in England and America.

Information on two Doggett families in America was collected and compiled by Samuel Bradlee Doggett in the History of the Doggett/Daggett Family. They were the families of John Doggett of Martha's Vineyard, Massachusetts who was a pioneer in Watertown, Massachusetts in 1630 and of Rev. Benjamin Doggett who was in Lancaster, County, Virginia by 1670.

John was the uncle of Rev. Benjamin Doggett. It is known by the St. Mary le Power Church records of Ipswich, County Suffolk, England that Rev. Benjamin Doggett was christened there on 28 October 1637. He was the son of William Doggett baptized at Boxford, County Suffolk in 1599. William was the brother of John who was baptized at Boxford, County Suffolk in 1602. William and John were sons of William Doggett and Avice Lappadge of Boxford.

### DOGGETT BRASS IN BOXFORD CHURCH

On a brass plate with scroll work and other devices, placed between four separate shields (the Arms of the City of London, of the Merchant Adventurers &c) is the following inscription:

Here lyeth Willia Doggett Marchant Adveterer Citizer and Mercer of London and free of the East India Company who tooke his wife Avis Lappage ye daught, of Thomas Lappage of Boxford with who he lived for 19 yeares & had Issue by her 6 sons & 6 daughters ye said Will depted this life ye 10th of Octob. 1610 being the age of 53 yeares.

### DOGGETT SURNAME:

The Doggett surname is one of the oldest in England. It is in the records as early as the 12th century. The name first appears as Duchet (Ducket) and as late as 1601 there was some confusion in regards to "Doggett" and "Duckett".

### COAT OF ARMS:

The coat of arms pictured is one of about a dozen Doggett/Daggett English Coat of Arms.



The greyhound figures prominently in their coat of arms. In olden times the greyhound was not allowed to be possessed by any save the princes and nobles until much later times. The killing or maiming of one was a felony punishable with death. The use of the greyhound is coursing. The great event in coursing circles in England is the "Waterloo Cup" of considerable value, which is run for at Altear, near Liverpool, annually.

The term "greyhound" is a corruption of the word "gazehound" signifying that it pursues its games by sight and not by scent.

Description of arms: Sable, two greyhounds combatant, or.

### WILL OF REV. BENJAMIN DOGGETT

In the name of God Amen: I, Benjamin Doggett, minister of Lancaster County, being sick and weake in boddy but of sound and perfect memory, do make this my last will and testament as follows:

1st I bequeath my soul and boddy to God the giver and my boddy to be decently buried before the pulpit in the Chapel Church.

2nd I give unto my eldest son Benjamin Doggett, a hundred and fifty acres of land, beginning at the water side and to run right across from the line that parts me and Thomas Tomson to Jon Cook, and in case he dyes without issue male, then the land to be equally divided with the orchard, between my two sons Richard and William and in case my son Benjamin shall marry before he arrives to ye age of two and twenty, he shall thereby forfeit all his title and interest in said land and the land to be divided as above mentioned.

3rd I give unto my son Richard Doggett, one hundred acres of land and in case he dyes without issue male or marries before he arrives to the age of twenty-two then the land to descent to my son William Doggett the shares...without of his share in my personal estate as will purchase him a part of the land to be...for him. sarbts afterward to be bought for him as his estate will admit of. If sarbts cannot be purchased the Tobb (tobacco) to be disposed of to ye best advantage.

4th I give to my son William Doggett, one hundred acres of land and in case he dyes without issue male or marries before he arrives at the age of twenty two, then ye land to be divided between my two daughters Jane and Anne Doggett, a part to be purchased for him out of his share in my personal estate the land seated and other parts to be bought for him as his estate will admit of, to ye best advantage, those two hundred acres given my two sons Richard and William to be divided at the discretion of my Executor.

5th I give unto my daughter Jane Doggett in England, twenty shillings and no more because she have been detained from me and surely is provided for.

6th I give unto my daughter Anne Doggett, fifteen thousand pounds of Tobb, six young cows, six breeding sows to be paid for by my 3 sons Benjamin, Richard and William provided she doth not marry before she arrives at the age of eighteen, ye lott to be at two yearly payments, one half the first year and the other half the next year, her name and age to be registered in the book of Crist Church parish and likewise my two sons borne in Virginia, their agge you must have from their mother.

7th Because there remains six thousand pounds of Tobb to be paid Mr. Flower and some other lott if the Tobb allowed me by ye parishes and with my sarbts make will not dephrey them, then so much to be sould out of my personal estate to be equally divided between my wife and children only debaring my son Benjamin any share amid share in ye cattell because he have good stock of his own.

8th My wife to have her accommodations as long as she continues a widow but if she marries, she shall desert the plantation, my two sons and my daughter Ann to have their accommodation with my son Benjamin till they are capable to live on their own.

9th. The pipe stands to be sold for money... Sawers to be employed to saw just planks to be sold for money to pay Mr. Griggs.

10th My books to be appraised, a great chest to be bought, ye books to be packed up and sent to England to be sold, ye overplus of monies that remains when Mr. Griggs is paid, I give unto my living wife Jane Doggett desiring her to buy mourning ring with this purpose, following more

11th I do constitute and appoint Mr. Shraphoard, Mr. Stirmaold (?), Mr. Atkins, Mr. Wilkes ye appraisers of my estate. Mr. Thomas Marlin, Mr. Joth Mullis executors to this my last will

and testament and for their trouble I give unto both my executors 20 to buy the mourning rings.

In witness whereof I have hereunto put my hand and seal fourteenth Day of March in ye year 1681.

Note: The pay of Rev. Benjamin Doggett was evidently in tobacco. The pay of an earlier minister was 10,000 pounds of tobacco "in cask". The Vestry men were supposed to collect the tobacco and deliver it in casks ready for sale. A boxed compartment for receiving tobacco was built in Old Christ Church. All persons were required to attend church services on Sundays. A fine of 50 pounds of tobacco was imposed on those who failed to attend (Anna Doggett in "History of the Doggetts of Guillord County, North Carolina," p 8)

### A TRIBUTE TO REV. BENJAMIN DOGGETT

On Sunday July 5, 1959 a bronze memorial tablet in memory of Reverend Benjamin Doggett was unveiled in St. Mary's White Chapel where his body lies under the chancel. The tablet was presented by his descendants. An article from the Rappahannock Record on July 6, 1959 reported.

## MEMORIAL TABLET UNVEILED SUNDAY TO FIRST RECTOR

A tablet was presented and unveiled at St. Mary's White Chapel Sunday July 5th by Mrs. Roger Donaldson on behalf of the descendants: Mrs. Calvin Forester, Port Arthur, Texas; Mrs. Exa D. Clark, San Augustine, Texas; James Anderson Doggett, Greensboro, N.C.; Anna W. Doggett, Princeton, W. VA; Mrs. E.C. Hope, York, S.C.; Denzil Doggett, Indianapolis, Ind.; Mrs. Hamilton Kellen, Silver Spring Md. and Mrs. Roger I.Donaldson, Morattico in memory of the first permanent rector of St. Mary's White Chapel, Rev. Benjamin Doggett.

He was the son of William Doggett of Ipswich, England where he was born in 1636. Rev. Mr. Dogget was educated at Cambridge University in England where he received his bachelor of arts degree in 1658/9 and his master of arts degree in 1662. After being schoolmaster in Stoke, England, he came to colonial Virginia before 1670.

in 1670 he was presented to the governor of Virginia for induction as rector of Trinity Parish. He became rector of St. Mary's White Chapel and rector of Christ Church Parishes and served until his death in 1682. His devotion for St. Mary's White Chapel summed up in these few words, "bequeath my soul and body to God that gave it, my body to be buried before ye pulpit in St. Mary's White Chapel."

The authority for previous history on the memorial tablet to be unveiled was by Dr. G. MacLauren Brydon, court records and "Colonial Churces in Virginia" by Dr. Goodwin.
