- Isaac: A Quaker; member of Quaker Meeting House on Bush River, Newberry Co. SC. Was one of few who did not remove to Ohio and Indiana in exodus of 1800-1807. His daughter, Phoebe, married Dr. Marauduke Thomas Mendenhall, q.v. -Annals of Newberry, pp 29, 133.
- Phoebe: Dau. of Isaac Kirk; m Dr. T.M. Mendenhall, q.v.
- William: Will. Good Christ Church Parish, Ga. 1770 by Isaac Young, qv, to Jonathan Bryan.
