In recent searches Marsh additional checking has been done in Georgia records early. I would still have sources in records in Georgia to check if you wish another time. Oldest references in Georgia have now been checked which are here at this library.

On the Billingsley I have done more proofreading and found that the book on the Billingsley's stated earliest families in England from county Salop which is now Shropshire so decided to change the name to what the area is now with your being made aware as to why I changed the area from county Salop to Shropshire. Further in the book some of sources actually reported county Salop, Shropshire which would not be accurate. Older names on the Billingsleys pedigree are kept track of by the reigns of English kings and not by regular birth dates when families are of the nobility. Any coats of arms would be registered in King's court, thus any events would be recorded for the reigns of the kings in which they took place.

Note the updated charts for families on the Sessions I have included additional data from previous names including another sheet on a John early in Alabama in an 1830 census, whether he is same John with wife, Sarah, who later appears in our target county with your Richard is not proven from available records, Please note my comments on both the John with wife, Sarah and dau. Susannah and the other sheet on John B. These could be the same family or two different families. The problem is there was no probate on these John's to help identifying all given names of family members.

Only other possibility would be if a descendant would have a family bible record to establish the children's names on John or John B.'s wife and children to see if wife's would both be Sarah? etc. etc.
